1. Characteristics

Padded elbow strape consists of a strap fastened by Velcro and a silicone pad which affects attachments of the muscles with a controlled pressure. The insets of the silicone pad perform a micro-massage while movements of elbow joint reducing the pain. The strape reduces the risk of overloads or tears of muscle attachments of extensor and flexor of the forearm and hand.

2. Application

Elbow strape is used in medical treatment in order to relief the area of condyles of humerus.

Indications for use:

- Tears and strains of proximal attachments of the forearm muscles
- Acute and chronic pain syndrome
- Non-invasive treatment
- Preventive treatment of sport injuries

Contraindications:

Do not use in case of:

- Skin abrasion
- Eczema
- Wound and other skin injuries
- After application of warming gel or ointment
- Individual contraindications which were determined by the doctor during interview and physical examination

4. Fitting instruction

- Put the strape on with silicone pad placed in the area of lateral epicondyle of humerus. Wrap the strap below elbow joint and fasten with Velcro.
- When the strap is too long, cut its end using scissors to the appropriate length so that it can be attached to the strape.

Note! Only properly matched size reduces the risk of overload and strain of muscle attachments of extensor and flexor of the forearm and hand. Long-term use may result in reduction of muscle tone and dysfunction of the limb.

- Ensure the Velcro is properly fastened in order not to damage the material.
